1	President's Welcome	
	The Chairman of the 2018 AGM, call for the meeting to order at 7:00pm. In accordance to paragraph 7.1 of the TAS Constitution, the quorum for the AGM had been met.	
	The chairman, DH welcomed everyone to the 2018 AGM, and introduced the incumbent Management Committee members. DH hands over to EO to present the AGM.	
	EO shared the Agenda for the meeting, the Vision, Mission and Value Statements (MVV) of TAS.	
2	To approve and confirm the minutes of the 2017 AGM	
	The minutes of the 2017 AGM held on were unanimously approved and confirmed with no amendments made.	
	The acceptance of the minutes were proposed by RC and seconded by SC.	
3.	To approve and confirm the Annual Report for the year ending 31 March 2018	
	The Chairman invited members to seek any clarifications they might have on the Annual Report.	
	PH pointed out that his name was missing from the list of SFTO for Subic Bay race.	
	CS seeks clarifications on the low number of Ordinary and Affiliate Members, in relation to the substantial number of Triathlon Clubs in the fraternity. EO clarified that a number of these clubs are not interested in being represented by TAS, and acknowledge that TAS can do better in this aspect, through better communication and planning.	
	YZ seeks clarification on the low number of Individual Members, but high participation numbers in our local sanctioned events, as evident with the number of Day-of-Race Members. EO clarify the lack of capability and resources to attract DOR Members to convert to annual members, as TAS needs to strike a balance between increasing membership and providing support for event organisers in this down-period. As such, TAS had kept DOR membership fees at a minimal over the years.	
	CS, JM, JZ seeks clarification on the sanctioning of local events, that organisers should increase DOR fees or TAS will not proceed with sanction. EO explained that all multi-sports event (conducted in a public area) in Singapore should be sanctioned by TAS, since there is a certain level of risk involved in our sport. Any unfortunately fatalities in a multi-sport event, regardless of sanction status, will have to be answered for by TAS. TAS will endeavour to work with relevant agencies issuing permits and venue operators, to ensure that Triathlon event organisers seek sanction from TAS. EO also clarified that events conducted in private venues like schools or swimming pools, are encouraged to apply for sanction, with a waiver of any sanction fees.	

There were no further clarifications or queries from the members for the Annual Report. The Annual Report for the year ending 31 March 2018 was unanimously approved and confirmed.

The acceptance of the Annual Report was proposed by DS and seconded by EL.

4. To approve and confirm the Annual Financial Statements for the year ending 31 March 2018

EO informed that the Statement of Accounts for the year ending 31 March 2018 was audited by Strategic Audit Alliance PAC, and had given the opinion that financial statements are properly drawn so as to give a true and fair view of the state of TAS, in accordance with the provisions of the Act, the Charities Act and Singapore Financial Reporting Standards.

The Chairman invited members to seek any clarifications they might have on the audited Statement of Accounts

CS seek clarification on net liabilities of \$45k. DH explained that since FY2009 to FY2011, the statement of accounts registered negative surpluses and huge accumulated deficits, due to the financial crisis from our event sponsors, as well as failure of TAS's business unit. Since then, it had been a very commendable effort that TAS has managed to reduce the amount to the current amount, especially with reduce funding and reduce support from sponsors. Since FY2011, the association had been registering surpluses every financial year to reduce the accumulated liabilities and will continue to do so in the coming years, through strategic planning and running of the association, without any compromise on our focus of developing the sport and athletes. We had also spoken to affected creditors, whom had gave their support in allowing TAS to make gradual payments.

There were no further queries from the members, and the audited Statement of Accounts were unanimously accepted and endorsed by the members.

The acceptance of the Statement of Accounts was proposed by RC and seconded by DW.

5. <u>Election of the Executive and Management Committee for the next term, 2019 to 2020</u>

Chairman of the 2018 AGM, called for the Election Proper, to vote in the Management Committee for the next term 2018 to 2018.

Chairman shared with members on the primary roles of TAS MC, and the election procedures.

Chairman then quoted the TAS constitution para 4.2 that explain "... Ordinary Member shall have one vote."

Chairman identifies that TAS currently have 4 Ordinary Members and all 4 was represented in this AGM. (Bike Aid, Breakaway, TeamFabian, PCFS)
